### **❖** Coastal RSM Plans

- o AMBAG
  - Monterey Bay National Marine Sanctuary provided Letter of Support for Coastal RSM Plan.
  - Congressman Farr interested in assisting in implementing CRSMP for southern Monterey Bay
  - City of Monterey Council voted to recommend AMBAG adopt the CRSMP, with 4 conditions that are mostly addressed in the Plan.
  - AMBAG Board of Directors will (hopefully) adopt the CRSMP tonight (9/10/08).
    - This has no impact on the LCPs, but it contains recommendation that LCPs incorporate the CRSMP. Some of the cities are looking to update their LCPs or LUPs and may include the CRSMP in their planning process.
  - Sand City Resort project is moving forward. Mark concerned that the CRSMP recognize this is going on. CRSMP would not be



- accepted by locals or AMBAG BOD if it precluded pre-approved projects.
- Request made to put together a "Lessons Learned" during development of the CRSMP.

#### o SANDAG

- San Diego CRSMP schedule for submittal of initial draft to Clif/Heather has slipped to September 30.
  - Will not be put up for adoption by SANDAG until CSMW has reviewed the report and given OK.
- Contract for San Diego Environmental Assessments of selected receiver sites has been executed.

### BEACON

- Initial draft CRSMP due to Clif/Heather this month; public meeting most likely to be in December.
- DBW has provided additional funding for BEACON to develop an implementation plan.

### LA County

- Los Angeles CRSMP is beginning to get setup kickoff meeting to be scheduled by USACE LAD.
- Need to make sure the plan involves State Parks.
- Santa Monica Bay Commission potential regional partner?
- Talk with County Planning Agency

### **❖** Next CRSMPs?

- o Fundina
  - CIAP funds (~\$700K) now estimated to be available January 2009
    - \$100K for half-time GIS Specialist for 2 years
    - \$300k each for two Plans and associated environmental work (experience indicates this may not be enough to complete both efforts)
    - DBW has provided AMBAG and BEACON \$150K each for environmental work beyond CRSMP
  - Corps funds (\$900K)
    - 2 Plans (Just Plans)
- Potential Areas
  - Orange County This area recommended if regional entity signs on as it will complete southern California
  - Morro Bay
  - Coastal San Francisco (include San Mateo?)
  - Santa Cruz littoral cell (Santa Cruz and San Mateo counties)
  - Santa Cruz County
  - San Francisco Bay (effort would look at needs and overall plan on how to attack issues and funding) – look at ABAG boundaries



(include San Mateo, Santa Cruz, SF Bay) – Brenda will approach ABAG and Bay Area IRWMP about their interest in doing a CRSMP. Mark Johnsson, Mark (Corps) and Clif can attend to present efforts to date

  - Sand Mining permits in process
  - Go after Prop 84 funding to supplement funding

- Once received, Karen Green will need additional funding to incorporate all reviewer'w comments
- Common comment is need for a condensed, "User's Guide" to facilitate use of the document

- ❖ **Spatial Data Website** up and running on the CSMW website

### Sediment Master Plan Status Report 2008

- 1. Time is short if we are to get an update done in 2008. Resources are needed, workgroup meetings need to be set up, vision/content determined, and Status Report developed.
- 2. At today's meeting, we should at least identify who is going to participate and when the first subcommittee meeting will be held.

### **Coastal RSM Plans:**

- 1. Monterey Bay National Marine Sanctuary provided Letter of Support for Coastal RSM Plan.
- 2. Congressman Farr interested in assisting in implementing CRSMP for southern Monterey Bay
- 3. City of Monterey council voted to recommend AMBAG adopt the CRSMP, with 4 conditions that are mostly addressed in the Plan.
- 4. AMBAG Board of Directors will (hopefully) adopt the CRSMP tonight.
- 5. San Diego CRSMP schedule for submittal of initial draft has slipped to September 30.
- 6. BEACON draft CRSMP due for review this month; public meeting scheduled October/November.
- 7. Los Angeles CRSMP is beginning to get setup- kickoff meeting to be scheduled by USACE LAD.
- 8. Contract for San Diego Environmental Assessments of selected receiver sites has been executed.

### California Beach Restoration Survey (CBReS)

- 1. Updated report has been out for review since July. Comments from CSMW (if any) will be discussed today.
- 2. Have received comments from SANDAG (Tucker), BEACON (Comati, Moore) and Sanctuary (Damitz). All like the report and had minor edits- Moore provided additional sediment sources for inclusion in summaries
- 3. Conducted final edit review assuming no additional substantive changes are forthcoming. All edits currently in hand will be addressed and the report provided to Brian/Chris for policy review next week.

Tijuana Estuary Sediment Study (TESS)



- 1. 401c Cert has been issued by RWQCB- Conservancy seeking to modify one condition
- 2. Coastal Commission hearing is today (September 10).
- 3. SCC pursuing additional funds to address biological monitoring and other additions to project requested by agencies
- 4. Pre-construction surveys may be done in September if contract is executed in time.
- 5. Need to hear from Rob Smith soon regarding status of USACE permit.
- 6. First placement scheduled for mid/late October- we're almost there!!

### GIS/IMS

- 1. The Spatial database website is up and running on the Resources Agency server, and available through a link on the website.
- 2. John Carotta remains deployed on the fire assessment teams and will begin debugging the website when he returns.

### Coastal Sediment Benefits Analysis Tool (CSBAT)

- 1. The tool was used to conduct Benefit:Cost analyses for alternatives in southern Monterey Bay CRSMP. Initial runs did not indicate BCs>1 for various nourishment scenarios. PWA reran model adding in cost savings associated with delaying onset of erosion, and followup runs indicated BCs>1.
- 2. USACE provided comments and they are being addressed.
