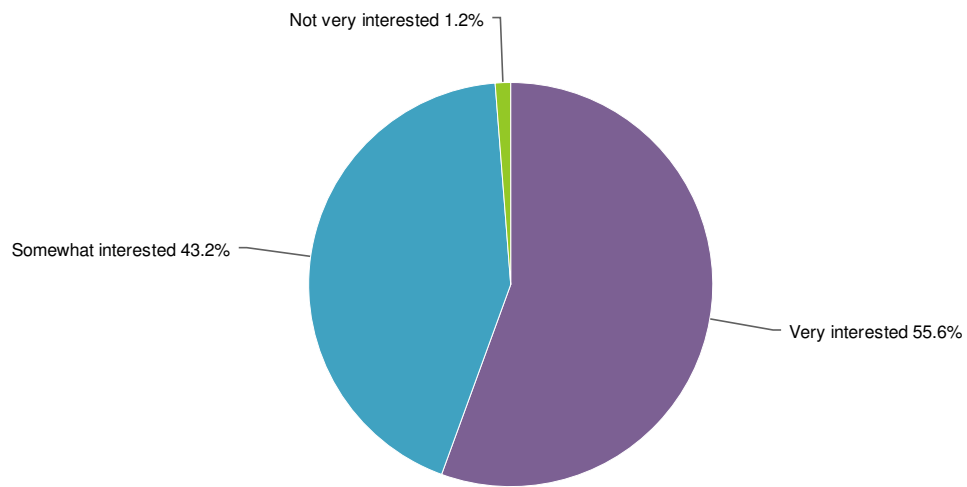

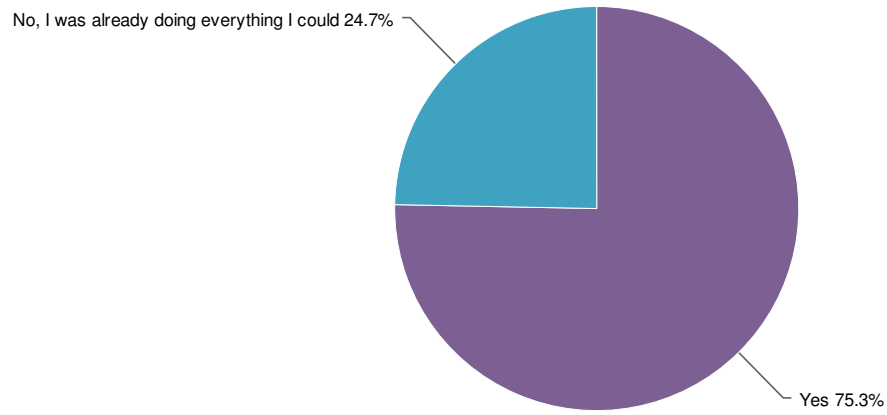

4. How did boaters respond to your face-to-face boater education and the boater kits?



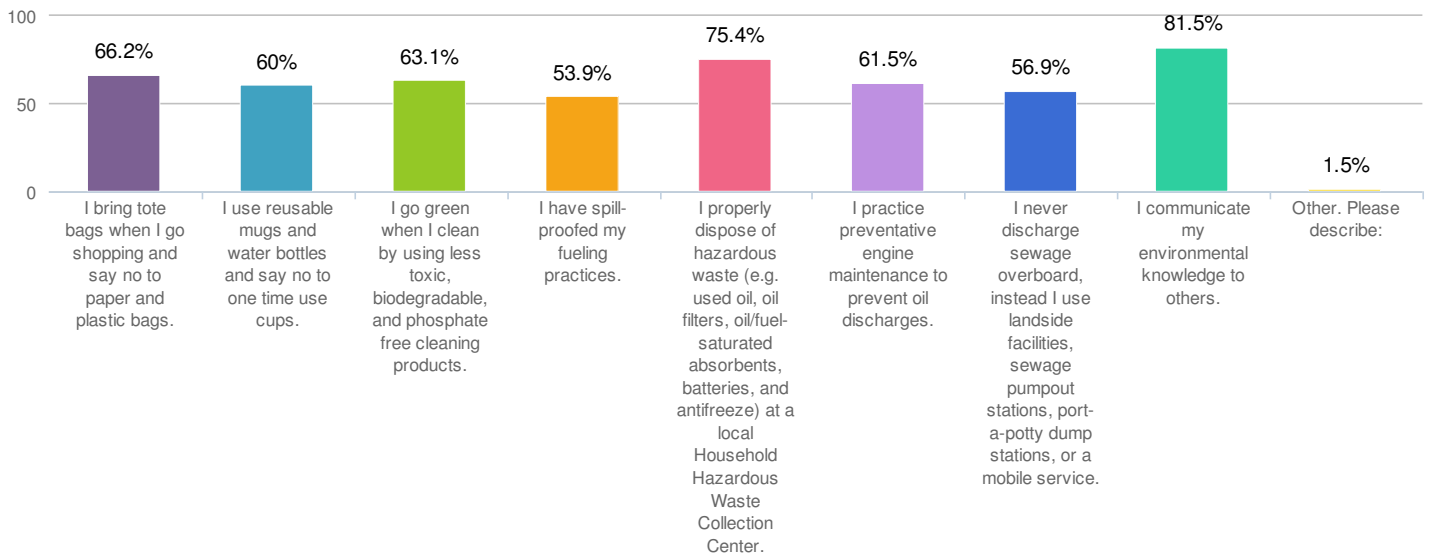

1	What kind of changes are being made to the Dockwalker program that reflects the feedback and survey information that we gather from year to year? What are we doing to address different demographics within the boating community? We need audience specific surveys to more accurately assess what people know and gauge their boating behavior.
1	maybe offer more information for chances to distribute information. Such as events, openings, fairs, etc
1	I think that Spanish language surveys/materials could be a really useful tool for boater outreach in California. We contacted a lot of Spanish speakers and it was difficult to get through the surveys even when they had someone to translate the questions for them.
1	I usually multi-task, and tie in the surveys with the Free Vessel Safety check program that the U.S.Coast Guard Auxiliary dose. Also taking to Crew members that work on other peoples boats ,can be helpful. They can pass on information to the Skippers.They crew with.Or know when something is done that isn't right. and pass on the proper procedures/information.
